AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 22 MAY 2019 FOR THE TOOVERBERG WIND ENERGY FACILITY (WEF) AND ITS ASSOCIATED INFRASTRUCTURE NEAR TOUWS RIVER, WITHIN THE WITZENBERG LOCAL MUNICIPALITY, WESTERN CAPE PROVINCE

The Environmental Authorisation (EA) issued for the above application by this Department on 22 May 2019 and your 'request for the correction of administrative errors included in the Environmental Authorisation' letter, received by this Department on 23 January 2020 refer.
